



Terms and conditions

Prize competition « Eggstravaganza 2023 »

Article 1 – Arrangement

In the framework of a marketing campaign aimed at promoting the shops at Luxembourg Airport, the company “Société de l’Aéroport de Luxembourg S.A.” (lux-Airport) offers a game under the name “Eggstravaganza” which includes a prize competition based on the upload of pictures and correct answers to a quiz.

The limited timeframe for participation in this prize competition extends from 30 March 2023 until 24 April 2023.

Article 2 – Eligibility

The prize competition is meant for all passengers and visitors of the terminal building of Luxembourg Airport.

To be eligible, participants must comply with all of the following conditions:

- Be a physical person who is at least 18 years of age on the day of participation.
- Employees of lux-Airport, SSP, Lagardère, Valora, and Signorini Tartufi cannot participate in this prize competition. Participation of their family members is also prohibited.

Article 3 – Participation

To participate, the passenger/visitor needs to take a picture of themselves or their beloved ones in the Eggstravaganza display area, scan a QR code linked to the lux-Airport website where they can submit the picture for preapproval, answer a quiz and write their name, email address, nationality, and destination.

After completion of the quiz, the first 1500 participants to the game will instantly receive a voucher to pick up a free chocolate bunny upon 10€ purchase in any of the following Airport shops: Starbucks, Press & Books, Comptoir du Bon Pays, Aelia Duty-Free, Panopolis, Moselier, Petit Moselier, Lux-Brewery, Sandwiches & Cie.

To participate in the final draw, the passenger/visitor needs to have answered correctly all the quiz questions.

The nationality and the destination replies are collected exclusively for survey and market research purposes; the email addresses are collected exclusively for the determination and notification of the



winners. They are going to be deleted after the end of the marketing campaign unless the participants actively tick the box to register for the lux-Airport newsletter.

The author of the uploaded pictures grants lux-Airport a limited, revocable, non-exclusive, worldwide, and royalty-free license to publish the uploaded pictures on its social media.

The pictures uploaded are submitted to a prescreening process performed by lux-Airport before publishing and lux-Airport reserves the right to select the best pictures that will be shared on social media.

Article 4 – Prizes

Every participant who uploads a picture and answers correctly to all questions of the quiz takes part in a random draw, where he/her can win prizes.

The following prizes will be raffled:

- 1st prize: Easter basket with products from the Airport Terminal shops - Oberweis, Starbucks, Press&Books, Aelia Duty-Free - for a total value of 500 euros;
- 2nd prize: Easter basket with products from the Airport Terminal shops - Oberweis, Starbucks, Press&Books, Aelia Duty-Free - for a total value of 300 euros;
- 3rd prize: Easter basket with products from the Airport Terminal shops - Oberweis, Starbucks, Press&Books, Aelia Duty-Free - for a total value of 200 euros;
- 4th prize: Easter chocolate basket sponsored by Genaveh, for a total value of 120€ euros.

All of the prizes will be raffled at the end of the commercial campaign. The winners will be announced until 5 May 2023 and contacted via email. The prizes can only be collected in person at Luxembourg airport. The random draw of the 4 winners will be handled by lux-Airport. Every email address is only counted once and playing the game several times does not increase the chance of winning a prize.

Article 5 – Limitation of responsibility

lux-Airport incurs no liability for the organization of this prize competition, especially if, in case of “force majeure” or any events beyond its control, it is necessary to cancel, shorten or postpone the prize competition.

Except for serious or willful misconduct, lux-Airport is not liable for any problems caused by the organization of the prize competition, the participation in the random draw, the nomination of the winner, the attribution of the prize, and the usage thereof.

Aside from stipulations under the present terms and conditions, the winner cannot contest the offered prizes. The obligation of lux-Airport ends with the handout of the prizes to the winner.



Article 6 – Personal data protection

The uploaded pictures, coordinates, and identifiers of the participants are used in accordance with European Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data. They are used for the sole purpose of conducting the prize competition “Eggstravaganza” and for social media communication in relation to this prize competition. The personal data provided by the participants will be treated in accordance with lux-Airport’s personal data protection charter which can be consulted on our official website :

Article 7 – Accessibility

The contents of the present terms and conditions are available on the dedicated page of our website and will be given free of charge to the participant, upon simple request to lux-Airport.

Article 8 – Invalidity

Should any provision of the present terms and conditions become void for whatever reason, it shall not affect the validity of the present terms and conditions as a whole.

Article 9 – Litigation

All matters the participants wish to contest about the prize competition must be sent in writing with acknowledgment of receipt to lux-Airport before the 5th May 2023 at 23:59 (date of reception). All disputes arising thereof that cannot be settled amicably fall under the exclusive jurisdiction of the Luxembourg Courts and Tribunals with material competence in such matters.

The present terms and conditions are governed by Luxembourg law.
