

Terms and conditions Prize competition « Summer Game »

Article 1 – Arrangement

In the framework of a marketing campaign aimed at promoting the shops at Luxembourg Airport, the company "Société de l'Aéroport de Luxembourg S.A." (lux-Airport) offers a digital game under the name "Summer game", created by company Adictiz, which includes a prize competition based on Trivia videogame scores.

The limited timeframe for participation in this prize competition extends from 12 July 2025 until 20 August 2025.

Article 2 – Eligibility

The prize competition is meant for the customers of the shops of our commercial partners located inside the terminal building of Luxembourg Airport.

The selected shops are the following: Starbucks, Oberweis Shop, Press & Books, Aelia Duty Free, Panopolis, Moselier, Lux-Brewery, Petit Moselier, Sandwiches and Cie.

To be eligible, customers must comply with all of the following conditions:

- Be a physical person who is at least 18 years of age on the day of participation.
- Employees of lux-Airport, SSP, Lagardére, Valora, cannot participate in this prize competition.

Article 3 – Participation

In order to participate, customers have to scan a QR code that will be shown on all JCDecaux digital screens in the airport, in A4 format in the shops and on social media; they will have to insert name, surname, email address, their origin and their destination and then play the videogame. Depending on the obtained scores, the participants will then receive an email, which may include several discounts and vouchers that can be instantly redeemed in the shops and restaurants at Luxembourg airport. Each participant has three attempts to play the game but can win only one coupon for all the duration of the campaign.

The participation is voluntary and totally free of charge. The email addresses are collected exclusively for the determination and notification of the winners. They are going to be deleted after the end of the marketing campaign, unless the participants actively tick the box to register for the lux-Airport newsletter.



Article 4 – Vouchers from SSP, Valora and Lagardère

Granted vouchers offered by our partners SSP, Valora and Lagardére will be sent per email to the winners for use in the shops and restaurants at Luxembourg airport.

The coupon can be used in the store on a wide range of products, excluding gift cards, prepaid card, tobacco, nicotine products, press, lottery products.

In order to use one of the discounts and vouchers, you must present the received coupon in person in the respective shop or restaurant. All of the coupons are only valid starting on the day of receipt for a maximum duration of 1 month. There is no entitlement to use a coupon when a restaurant or shop is closed. Discounts can only be redeemed once per person. All coupons must be redeemed in a single



store and in a single transaction. The coupons cannot be redeemed for cash. The total quantity of coupons is 1800.

Article 5– Limitation of responsibility

lux-Airport incurs no liability for the organization of this prize competition, especially if, in case of "force majeure" or any events beyond its control, it is necessary to cancel, shorten or postpone the prize competition.

With the exception of serious or willful misconduct, lux-Airport is not liable for any problems caused by the organization of the prize competition.

Aside from stipulations under the present terms and conditions, the winner cannot contest the offered prizes.

Article 6– Personal data protection

The coordinates and identifiers of the participants are used in accordance with European Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data. They are used for the sole purpose of the prize competition "Airport's Egg Hunt".

Additional data the participant provide on a voluntary basis may be used by lux-Airport for purely statistical purposes kept anonymous.
